**P/2018/0497** for VAR: Section 73 application to modify condition 4 of planning permission B/00/0093 relating to operating hours at Black Mountain Activities Outdoor Pursuits Centre Three Cocks Brecon Powys

**P/2018/0481** for VAR: Section 73 application to modify condition 5 of planning permission B/02/0010 relating to operating hours at Black Mountain Activities Outdoor Pursuits Centre Three Cocks Brecon Powys

Mr Simon Guinane, who owns the neighbouring residential property, spoke against this application. This related to comments in the original planning permission which stated that due regard must be given to ensure that any development does not impact detrimentally upon this residential property, and that there is a very serious safety issue with the current paintballing activity that would be exacerbated if the operating hours were to increase. A full copy of Mr Guinanes notes is held in the minute book.

Following further discussion on the points raised by Mr Guinane, it was agreed to send the following response:

That the Community Council opposes any such extension to the operating hours until such times as other breaches and contraventions have been satisfactorily resolved. The response will also include reference to the matters raised by Mr Guinane.
